## **Mission Statement**

When an incident is reported, our school is devoted to ensuring appropriate action is taken and a resolution is put into place which is both fair and firm.

- The LA SACRE RE Curriculum explores the beliefs and understandings of different religions.
- Anti-Bullying programmes and initiatives, including Anti-Bullying Week, workshops and assemblies.
- Links with the local community foodbank.
- A detailed PSHE programme.
- Community events, e.g. Jubilee fun day to which the local community are invited to attend.
- Fundraising for local and national charities including:
  - Blackburn with Darwen Age UK
  - Children in Need
  - Sport Relief
  - Cancer Research UK
  - Unicef
- Intergenerational activities, e.g. connection with local care home – choir visits.
- Community events such as taking part in the Commonwealth Baton exchange with other schools.

- British identity promoted through a range of calendared activities, including parents and wider community.
